Mayor's Letter

I would like to begin this month by thanking two council members, Matthew Dawson and Patrick Sivigny, who chose not to seek re-election and whose terms thus ended on June 30. These are two outstanding individuals who I have known for many years and with whom it was truly an honor to serve. Their consistent, calm, and considerate deliberation of matters in the best interests of the Town were an asset that will always be appreciated. With their departure I would also like to welcome our two new council members, Krystyna Bienia and Jenn Loges.

On June 16, the Town Council adopted our budget and tax rates for fiscal year 2021, which begins on July 1. All tax rates remain unchanged from the prior year. A summary table of the budget and tax rates is contained on the back page of this newsletter, and a more detailed summary may be found on the Town website (www.occoquanva.gov). In FY 2021 the Town will move forward with a micro-grant program for Town businesses that is summarized elsewhere in this newsletter.

This month we are poised to move into Phase 3 of Virginia's public health emergency re-opening plan. The most prominent changes will include additional retail openings and full indoor dining. Please note that both face coverings in certain locations (i.e. when one cannot social distance and when in indoor public venues) and social distancing are still required. There has been a surge in COVID-19 cases elsewhere in the country with an accompanying reestablishment of restrictions, which health officials attribute partly to noncompliance with social distancing and face covering recommendations. So, please help us avoid a similar occurrence by making a good faith effort to social distance and by always having a face covering handy.

As we begin a new Council and a new fiscal year I would like to once again thank you for your support during these difficult times and encourage you to contact me at eporta@occoquanva.gov with any questions, comments, or concerns.

Northern Virginia Enters Phase Three

Northern Virginia has entered Phase Three of reopening, effective July 1. Face coverings are required in public indoor settings and social distancing is strongly recommended.

- Restaurants and nonessential retail businesses allowed to operate at full capacity, with physical distancing measures
- Personal grooming services may accept walk-ins; masks and distancing required
- Social gatherings limited to 50 percent occupancy or 250 people, whichever is less
