

Town Council Actions: March 2021

- At the request of the applicant, postponed the public hearing on the Mill at Occoquan Special Exception Applications to a date to be determined.
- Held a public hearing and granted a lease to Occoquan Beer Garden, LLC for the use of 200 Mill Street (formerly Visitor Center) as part of a food and beverage operation.
- Held a budget work session on the FY2022 proposed budget.

FY2022 Budget Process: Information on the proposed FY2022 budget is available on the Town's website at occoquanva.gov. There will be a public hearing on the proposed budget on May 4, and on the proposed tax rates on May 18, with adoption scheduled for June 1, 2021. The 2022 fiscal year runs July 1, through June 30, 2022.

Occoquan Artisan Markets

The Artisan Markets will be hosted in River Mill Park along the beautiful Occoquan River on three separate weekends: each a sleek and distinct arts and crafts market individually curated from the work of juried artisans. The shows are held Saturday and Sunday from 10 am to 5 pm. As the event will be held within River Mill Park, town roads will remain open for traffic and parking. During these event weekends, timed parking restrictions will be temporarily lifted.



Patrons may take the free shuttles from the VDOT lot at Route 123 and Old Bridge Road or park in public parking areas within the Town, as available. New Visitor Information Kiosk Coming to Occoquan

Construction on the new Visitor Information Kiosk will start at the beginning of April. The Kiosk, located next to the Mill House Museum, will feature information from the Town of Occoquan and Prince William County. This kiosk is being installed by Prince William County and is replacing the operation of the Visitor Center. The old Visitor Center building, owned by the Town of Occoquan, will be leased out commercially as part of a food and beverage operation, expected to open later this year. Construction of the kiosk is expected to be completed by early May.

You're invited to the official ribbon cutting of the new free public Canoe and Kayak hand-carry launch on Saturday, April 24, at 10:00 a.m. While the ADA ramp has been open since September 2020, the official ribbon cutting event was planned for the start of the 2021 boating season.
