1. Call to Order

#### 3. Approval of Minutes a. September 26, 2023 Meeting Minutes

Commissioner Kisling motioned to approve the minutes. Commissioner Love seconded. The motion passed unanimously by voice vote.

#### b. October 5, 2023 Subcommittee Meeting Minutes

Commissioner Kisling motioned to approve the minutes. Commissioner Newell seconded. The motion passed unanimously by voice vote.

#### c. October 17, 2023 Subcommittee Meeting Minutes

Commissioner Kisling motioned to approve the minutes. Commissioner Newell seconded. The motion passed unanimously by voice vote.

#### 4. Discussion

Chairperson Perkins gave an update on the NVRC Trails Summit. He said he learned about funding, engaging communities, volunteers, safety, data, and mapping. Commissioner Somma said he learned about the VDOT criteria for trails and the prioritization of regional connectivity.

#### 4. Work Session

a. Beautification Work Group

Chairperson Perkins gave an overview of the new recommended template for work session artifacts. For the Beautification plan, he presented the Theme of Fostering a Distinct Identity for the Town and the Vision Statement, why the effort matters and why it benefits Occoquan. He said the program would use the notion of placemaking, beautification, and a public arts program to create special kinds of places that people want to visit multiple times. He gave an overview of the sections Past Accomplishments, what has OCQ done before; the SWOT Analysis; Goals; and Action items. For action items, he introduced the concept of pocket parks, empty spaces in Town that can be enhanced, such as the grassy area between Gift and Gather and Glory Be. He talked about incentives for weeding and maintenance for private property owners. He talked about establishing an Occoquan Volunteer core.

Chairperson Perkins requested feedback from the Commissioners on the document. Commissioner Somma suggested including a section for stakeholders and update action items table to align with Comprehensive Plan items. Commissioner Love said this document provides a framework and follows the same process as the Riverwalk Plan. Commissioner Wood asked if the document should include past failures or what actions other towns took that didn't work. Commissioner Love suggested past initiatives and what didn't work. For example, a lack of funding or in the SWOT analysis concerning municipal Wi-Fi. They found at one point the Town did have it, but it was overcome by technology and personal unlimited data plans and individual businesses providing Wi-Fi. Commissioner Newell noted Tanyard Hill as a past initiative.

Commissioner Kisling brought up the Town's status as a Bird Sanctuary as a theme and actions to support that. This included planting perennials around town that are lower maintenance and support birds, decorative bird houses in places, and the Audubon At Home program. Chairperson Perkins also noted Occoquan's status as a Tree City.

Commissioner Wood asked about going into specific ideas from the strategic framework. Chairperson Perkins said to email ideas.

Chairperson Perkins gave an overview of the proposed Public Arts Program. He said it will draw in visitors and contribute to community identity. He provided an overview of the goals and the NOVA Arts and Cultural District history. Commissioner Wood asked about funding for the Arts District. Chairperson Perkins there was none for this initiative.

Commissioner Kisling said that Henderson, North Carolina raised hundreds of thousands of funds with their Bearfootin' Art Walk & Auction. It provided 20 artist-painted bear statues which were auctioned to raise money for the non-profit. The company Icon Poly has a program to make paintable items such as these bears. Occoquan could do the such as for OCQ osprey, eagle, fox, that relate to this area. Puts OCQ on the map and on Instagram.

Commissioner Somma suggested drafting a Memorandum of Understanding (MOU) to define and track progress on the NOVA Arts and Cultural District. Mr. Whitmoyer said an MOU was created in 2017. It made the Workhouse the financial agent to create a logo, website, and sign off. The Town will need to follow up on it with the new leadership at the Workhouse.

Commissioner Love said that one element missing from the framework is who is responsible for each action item. Chairperson Perkins said there is a need for timelines as well. Commissioner Love suggested the same as was used for the Riverwalk roadmap, including long term, midterm, and short-

term goals. Mr. Whitmoyer said timelines and responsible parties can fit in with the Comprehensive Plan table.

Commissioner Wood said he was wondering if the Volunteer Corps is something overarching over all these initiatives. We have brilliant staff who are being overloaded with ideas. We need additional talent to get help. He noted the Food Rescue application, which makes volunteering very convenient. Chairperson Perkins agreed the Town needs to find a simple way to connect people.

#### 5. Discussion Items

#### a. Riverwalk Vision Planning Update

Commissioner Love gave an overview of the Riverwalk Roadmap. He said there are three high-level steps. The first step is the responsibility of the Planning Commission to identify why the Town benefits from a Riverwalk, and what are the options for a Riverwalk with pros and cons for each. At the end of step one is a decision by Town Council to proceed to step two and authorize funding. Step two is the development of a strategic plan. This actionable plan to move forward on the Riverwalk includes preconstruction activities such as assessments, surveys, architectural drawings, and other specifics with costs. Step one is short term and will be complete by December 2023, step two is longer term, and step three is the actual construction and contracting with firms. Step two includes Subject-Matter Experts (SMEs), Town Staff, and other responsible parties.

Commissioner Love said there were three options for proceeding on the Riverwalk. The first is a traditional basic boardwalk as a midterm goal with a long-term goal would be putting in bump-outs, a Ferris wheel, or other enhancements. The second option is to build it with all known enhancements. The third option is to not do anything, which is a throw-away option. Commissioner Love provided an overview of potential phases for implementing the Riverwalk.

Chairperson Perkins encouraged members to provide feedback. Mr. Whitmoyer asked if comments should be sent in emails or with collaborative working documents. Chairperson Perkins said to use working documents comments.

#### **Explanation and Summary:**

This is a work session to discuss the goals and action items related to making Occoquan a Trail Town. The work group of Chair Perkins and Commissioner Somma will present their research and conclusions and lead discussion on action items and next steps.

# Strategic Planning – Trail Town Program

## Theme:

## Vision Statement:

Amy Camp, author of Deciding on Trails, defines a trail town as, "a community through which a trail passes that supports trail users with services, promotes the trail to its residents, and embraces the trail as a resource to be protected and celebrated." Other terms for Trail Towns include "Gateway Communities" and "Nature-Base Placemaking." With four national cycling trails connecting the Town to Mt. Vernon, Fredericksburg, and other attractions; a prime location on the Occoquan River as a water trail; and a soon-to-be destination at the end of the Occoquan Greenway trail, Occoquan is a focal point for outdoor recreational traffic. This echoes Occoquan's history as a waypoint for travelers passing through after driving over the bridge that preceded today's footbridge. Occoquan's past and present are tied to the multimodal trails bound to it.

The Town also has an established character of promoting environmental stewardship and public health as a bird sanctuary, Tree City, and with its Friends of the Occoquan (FOTO) river cleanups. The trails running through Occoquan reinforce this identity in promoting alternative modes of transportation and physical fitness.

Economically, organizations, such as the Progress Fund, have published reports on how promoting a town's trails and incorporating them into the town's identity can promote economic revitalization. Additionally, the 2017 JMT Parking Study recommended "marketing Occoquan as a bicycle tourism destination and providing additional, strategically-located bicycle amenities for day trip and overnight riders." Regionally, there are multiple efforts underway in Northern Virginia and at the state level to connect regions via multimodal trails.

Occoquan is already a Trail Town. This recommendation includes actions to incorporate that character into the Town's programs and initiatives, promote that identity to visitors, and encourage travelers to stop in Town on their way to other destinations. <u>All of the efforts listed in this proposal to incorporate</u> <u>Trails into Occoquan's identity are efforts that benefit the Town as a whole.</u>

# Goals: Promote Occoquan as a Trail Town

SMART: Specific, Measurable, Achievable, Relevant, and Time-Bound. The art is to meet all five criteria in a succinct and understandable sentence. Succinct, widely understood language and keeping to 3-5 goals or less also helps focus resources and attention, increasing the likelihood of success.

- 1. Cultivate and promote Occoquan's existing identity as a Trail Town with historical markers, wayfinding signage, and attractions to bring outdoors enthusiasts into Town.
- 2. Establish reciprocal promotion between attractions and municipalities sharing trails with Occoquan via participation in regional summits, celebrations, and trail advocacy outside of the Town's jurisdiction.

3. Increase the value and accessibility of Tanyard Hill park with a volunteer maintenance plan, trail connections to the Occoquan Greenway, crosswalks, and clearly marked parking.

#### Yown Council Passes a Resolution Recognizing the Community Values its Trails:

<u>o Pending</u>

- Define an Occoquan Trail Town Vision:
  - Town Officials, Staff, and Citizens should collaborate on a shared vision of what a Trail
     Town program ultimately means and the "who, what, and how" of getting there.
- > Assess Community Interest in a Trail Town Program:
  - Solicit feedback from Town residents using a "Gut Check" survey to determine the feasibility of a larger Trail Town program that goes beyond what's outlined in this document.
- > Enhance Tanyard Hill Park:

 Occoquan has a wonderful resource in this park and needs to better protect and promote it. The Town should put up signage as part of entrance enhancement efforts, a crosswalk from the parking lot due to the heavy commuter traffic there, and clearly mark parking across the street from the park. Educational signage along the trail can also greatly enhance the hiking experience there.

#### > Build Trail Connections Between Tanyard Hill Park and Occoquan Greenway:

 A limitation for Tanyard Hill Park is that it is somewhat inaccessible byon foot to Occoquan residents, who must walk outside of Town along Old Bridge Road to reach the park. Connecting the park to the Occoquan Greenway will provide an accessible route to residents. The trails should be engineered by professionals and hopefully maintained by volunteers.

#### > Maintain Tanyard Hill Park:

• Set up a volunteer program for maintaining the trail in the park and the trails connecting the park to the Greenway.

#### > Advocate for a Trail Under the 123 Bridge in Fairfax:

- Almost all pedestrian visitors to Occoquan Regional Park come from the PWC side of the river. Entering the park on foot involves a steep hike up 123 road, crossing six lanes of traffic, and then a steep hike down into the park. A trail under the 123 Bridge into the park would increase its accessibility to foot traffic that is buffered to vehicular traffic and improve regional connectivity.
- Because the trail is outside of Occoquan's jurisdiction, but would benefit the Town, the Town should assist Fairfax with lobbying for the trail and finding grants.

#### > Post a "Trail Town"/"Gateway" information sign Near the Footbridge and/or 123 Bridge:

- The model for this sign would be the signs at the trails gateway into Harper's Ferry, which provides a map of the region, illustrates the many trails connecting to the town, and the attractions to which they lead.
- \_\_\_\_This sign would also include Occoquan's history as a waypoint for travelers.
- For trails included on this sign, it is important that the branding for the trails be consistent with that used in connected communities along the trail.
- Brochures with maps of the regional trails as well as advertising local businesses of interest to travelers may also be provided.
- <u>Reintroduce the "Walking Tour of Occoquan" as a brochure for visitors to curate their</u> visit, updated to include recent developments in the town such as Tanyard Hill Park.
- > Post Signs for the Potomac National Heritage Trail:
  - As a signatory, Occoquan needs to honor its commitment to the PNHT memorandum of understanding by placing signage for the trail at appropriate locations within Town.
     Representatives at NVRC recommended having the National Park Service put up the signs.

#### > Present a Yearly Progress Update at the NVRC Trails Summit:

 The NVRC has expressed a high level of interest in following Occoquan's efforts to establish a Trail Town Program. This yearly summit provides representatives from our Town an opportunity to present an update on our progress, participate in workshops for Trails advocacy, and network with other municipalities to enhance nearby trails outside of our jurisdiction.

#### > Participate in Trails Day:

 Hosted on the fourth Saturday of April, Celebrate Trails Day is an annual spring celebration of America's trails. Started by Rails-to-Trails Conservancy in 2013, the celebration encourages people across the country to get outside and enjoy the nation's exceptional trails and trail systems. Participating in this event promotes Occoquan's identity as a Trail Town.

- Town-Sponsored Geocaches:
  - Geocaching is still a very popular activity. The Town and local businesses can place geocaches around the Business district that promote local businesses and gather data on usage.
- Offer Camping in Tanyard Hill and Connecting Trails:
  - Occoquan's biggest weakness for threw-travelers along its trails is a lack of places to stay overnight. A cyclist who has travelled tens of miles will not stop in Occoquan for dinner unless there is a place to sleep nearby. Camp sites—preferably with showers offer travelers a reason to stay in Town as a destination instead of a lunch stop.

#### • Gather Metrics on Occoquan's Trail Use:

- "If you don't count, your trail doesn't count." surveys and tallies of trail users are needed to measure how many people use our trails and which trails are most popular. Metrics should also track how much money the average trail-user spends in Town.
- (Optional) Creation of a Local Advisory Committee:
  - As a long-term program, most trail town designations require a dedicated committee to inform the program similar to Mainstreet America. As there is currently no program for Occoquan to apply, this action would be optional.
  - The committee will provide guidance to the Town on Trail-Related Educational Programs, events, gathering metrics, and protecting the Trails.
- Pursue "Bicycle Friendly Community" status:

- Research Virginia's Statewide Comprehensive Outdoor Recreation Plan (SCORP):
  - Pending

- 1. Tanyard Hill Park: the Town has taken advantage of this property to preserve it as a natural resource and build a trail loop within it. The trail needs better access and maintenance to improve its usage.
- 2. National Arbor Day Foundation, Tree City USA Designation: this designation successfully takes advantage of Occoquan's natural resources.-
- 3. Bird Sanctuary: this designation takes advantage of the Occoquan river and other natural resources.
- 4. Friends of the Occoquan Cleanup events: <u>these events bring together connected communitees</u> <u>along the Occoquan River.</u>
- 5. **Tour of the Towns Cycling Event:** this event, starting and ending in Occoquan, took advantage of the cycling routes in PWC, and connected the Town to other communities in the County.
- 6. Kayaking/Paddleboarding Races: these events take <u>advantage of and promote the Town's</u> <u>water trail.</u>
- 7. **Mainstreet America:** the Comprehensive Plan lists enrollment in this program as being highly beneficial to the Town; however, the Town has never successfully assembled the required board of volunteers to work on this program. Forming a Trail Town committee faces the same challenge.

### Resources

**VDOT Virginia State Trails Office:** recently established office in VDOT, directed to Develop a State Trails Plan and State Trails Information Clearinghouse consistent with recommendations in the January 2022 Report of Virginia Multi-Use Trails Initiative.
