MAYOR'S LETTER

I would like to start this month by thanking everyone who helped decorate the town for Halloween, helped pull things together for the various Halloween-themed events in town, and who supported the Halloween parade. I have received numerous compliments from visitors, business owners, and residents about all your efforts.

During November, the holiday season kicks into high gear in Occoquan. This is one of the most important times of the year for Occoquan merchants, so as always, I ask that you please consider doing some of your holiday shopping in town, and encourage your friends and family to do so as well. On Saturday, November 9, from 1-5 p.m., over 60 local artists will be participating in *Art on the Block*, with receptions and art demonstrations at five locations. Then, on Friday, November 22, the Business Guild of Occoquan will hold its annual Holiday Open House from 4:00 to 8:00 p.m., followed at 8:10 by the town tree lighting ceremony at the Occoquan Town Hall, and then the Guild gift certificate drawings at 8:15 p.m. in front of Hawthorne House. This has become a very popular event for residents and visitors alike and I hope you will find attending enjoyable. Occoquan's holiday traditions continue in December as always. Make sure to check the December newsletter promptly for information on the annual town blessing at Ebenezer Baptist Church, the town holiday party, various charity drives (e.g. the Untrim-a-Tree, and Tree of Hope programs), and the arrival of Santa by boat (currently scheduled for noon on December 7).

Please note that Tuesday, November 5, is Election Day in Virginia, and this year will include a special election for a council seat in Occoquan. The polling location for town residents for this election is *Occoquan Elementary School*, and the polls will be open from 6:00 a.m. to 7:00 p.m.

Finally, I once again hope to invite the Salvation Army to have bell ringers in Town the night of the Guild Open House and Town Tree Lighting, and for that I need volunteer bell ringers willing to serve one or two hour shifts on the 22nd. Daylight Savings Time ends on Sunday, November 3, at 2:00 a.m., so be sure to set your clocks *back* one hour before heading to bed on Saturday night.

ARB — Did you Know

Did you know that chalkboards are the favored temporary sign in Occoquan? In the late 1990s, the Town made the decision to allow chalkboard signs in order to give merchants a temporary/changeable sign option. The subject was revisited in 2011, and after extensive research was conducted, the decision was reaffirmed by the ARB Task Force.

Specific details regarding chalkboard temporary signs may be found in Section 367 (17) of the Occoquan Town Code, which states the following: 1. Sign size shall not exceed two feet by three feet; 2. Sign frames shall be either wood or metal and may be black, natural wood tone, or similar historic color; 3. The chalkboards shall not have a pre-printed logo of any type; 4. Chalkboard signs must be placed away from doorways and the public right-of-way, and if leaning or standing, may not project more than two feet from the building; 5. Signs shall not be placed within any portion of the right-of-way; 6. Signs may be hung on the exterior of the building with hooks and eyes, leaned against the building independently or mounted on a stand.
