

ARB News: Business Representative Needed for ARB

On December 2, 2014, Town Council approved an amendment to the Town Code to add a business representative to the Architectural Review Board. This individual will serve as a liaison between the business community and the town in matters relating to the ARB within the Historic District. The representative is not required to be a town resident, but must own or operate a business within the town's limits. Mayor's Letter

The Town Council and Staff will soon be busy working on the fiscal year 2016 operating budget and capital improvement plan. In preparation, the Council is considering holding an offsite meeting this month to develop an organizational vision to guide the community over the next several years and set goals and priorities intended to achieve that vision and aid in the development of the upcoming and future budgets. The meeting will be a chance for the Council, still relatively new as a team, to have a focused discussion about its short and long-term goals for the community. It will be led by a facilitator, and give us an opportunity to have a realistic discussion about which of these goals can be accomplished with our existing resources, and where we might seek new sources of funding for others. The Council would appreciate public input on the topic of funding this offsite meeting, and would welcome comments at the January 6th Council meeting.

Also on the Council's agenda for the upcoming January 6th meeting is an item related to Town appearance. The Town has been selected to receive a bike rack grant, and will be installing twelve racks holding two bikes each in various locations around Occoquan. Last spring, it was suggested that the two parking spaces in front of Mamie Davis Park be removed so that racks could be installed there, opening up the view of the Park and river. Unfortunately, VDOT will not permit the racks to be permanently affixed to the road, though they are amenable to designating the spaces in front of the Park as a "loading only" zone to improve the view. As both Town appearance and parking are areas of concern in our community, the Council would like to invite public comment on this topic at our January regular meeting.

I hope you all enjoyed a safe and cheerful holiday season with family and friends, and I join the Council and Staff in wishing everyone in Occoquan a very Happy New Year.

Town Council Actions: December 2, 2014

The following items are extracts of recent Town Council actions and are not official meeting minutes. The most recent approved Town Council minutes and agendas are available online at www.occoquanva.gov. All votes are unanimous unless noted otherwise.

- Authorized a not-to-exceed limit of \$45,000 for the 2015 Spring Arts and Crafts Show, allowing the Town Manager to budget accordingly.
- Added a Business Representative to the Architectural Review Board.
- Postponed action on a proposed Council Retreat; deferred to January 6, 2015.
- Passed ordinance O-2014-05 Amending Town Code Section 62-111, generally related to illegal parking.

The landfill is open Monday - Saturday, 6 am - 6 pm; Sunday, 8 am - 5 pm and will be closed New Year's Day. Also, remember to bring a proof of residency with you.

Trash and Recycling Collection Reminders

Please place refuse to the curb **no earlier than 4 pm** on Tuesdays, but **before 7 am on Wednesdays**, and remove your containers as quickly as possible after collection. Ensure there is a pedestrian path available at all times by not blocking public sidewalks and rights of way with refuse containers. Place trash and recycling to the curb as normal on New Year's Eve.

Do not place household refuse in or next to Town-owned trash receptacles.



Parking Fine Increase

Parking violation fines within the Town have increased to \$50 from \$25. In addition, the pre-payable fine for handicap parking violations has increased from \$100 to \$150; however, the impossible fine range remains at \$100-\$500. The new fine structure goes into effect January 2, 2015.
