Afterwards, I met with staff to discuss some of the challenges and opportunities identified during the event, and we also brainstormed some enhancements for future shows to ensure our continued success. This is an incredibly important event for the Town of Occoquan, and a challenge for a staff of only seven people. Thanks to Events and Community Development Director, Julie Little, staff and volunteers for another great show. The countdown begins for Fall Show 2017!

A number of new businesses have opened this spring, so please join me in welcoming them to Occoquan: Grind N' Crepe, Reclaimed Treasures, Sistafriends Retail Store, Urban Posh Boutique, and Virginia Vapes. Though these storefronts are new, a number of them already have ties to other town businesses. We're proud to welcome these new ventures, and wish them much success.

Since March, staff and Town Council have been working with the land use and planning section of Burns & McDonnell out of Richmond, VA to review, revise and update the Town's zoning and subdivision ordinances (chapters 54 and 66 of the Town Code). The goal is to update these chapters for consistency to state regulations and compliance with other areas of the Town Code, as well as align them with the newly updated Comprehensive Plan document, adopted in October 2016. An introductory community meeting was held on April 20th, Council has reviewed various drafts during regularly scheduled Council meetings and work sessions, and a public hearing will be scheduled for August; please take some time to review the process and proposed changes at www.OccoquanVA.gov. We welcome your comments and concerns during this much needed review of the Town's zoning and subdivision ordinances.
