

## ARB News: Outdoor Merchandise Displays

Outdoor merchandise displays are allowed in the Historic District but there are parameters which should be followed.

Merchandise is to be displayed only during business hours and must be stored inside when the business is closed. No rack, table, display or storage apparatus can be in the public right-of-way or blocking an architectural feature (such as a railing, column, etc). Permanent display tables or racks are prohibited outside of buildings. In addition, no signs may be placed upon or hung from outdoor merchandise. ## Town Council Actions: August 5, 2014

The following items are extracts of recent Town Council actions and are not official meeting minutes. The most recent approved Town Council minutes and agendas are available online at [www.occoquanva.gov](http://www.occoquanva.gov). All votes are unanimous unless noted otherwise.

- Held a joint public hearing with the Planning Commission on the proposed Virginia Stormwater Management Program (VSMP) ordinance.
- Referred a proposed zoning text amendment to address ramps, structures and equipment for emergency services access to the Planning Commission.
- Endorsed the River Park concept plan and project schedule.
- Adopted an ordinance to amend Section 2-124 of the Town Code, Treasurer attendance at Town Council Meetings.
- Approved the purchase of a digital recording system to replace the current meeting recording system for an amount not to exceed \$5,000.
- Approved not-to-exceed limits for the Fall Arts and Crafts Show.

## Trash and Recycling Collection Reminders:

Please place refuse to the curb **no earlier than 4 p.m.** on Tuesdays, but **before 7 a.m. on Wednesdays**, and remove your containers as quickly as possible after collection. Ensure there is a pedestrian path available at all times by not blocking public sidewalks and rights of way with refuse containers.

**Do not place household refuse in or next to Town-owned trash receptacles.**

Did you know that you do not have to sort your recycling in Occoquan? Place all the materials in the recycling bin and set it next to your other refuse. In addition to common items like paper, plastic bottles and cardboard, you can also recycle hard back books, plastic lawn chairs, pie pans, paper milk/juice cartons, and empty aerosol cans. If you need a bin contact Town Hall and we can have one delivered to your home.
